Every education professional will receive preparation in the interconnectedness of the world with knowledge and skills, including language study.</p> <p>D. Every education professional will have 21st Century preparation and access to ongoing high quality professional development aligned with State Board of Education priorities.</p> <p>E. Every learning environment will be inviting, respectful, supportive, inclusive, and flexible for student success.</p> <p>B. Every school provides an environment in which each child has positive, nurturing relationships with caring adults.</p> <p>C. Every school promotes a healthy, active lifestyle where students are encouraged to make responsible choices.</p> <p>D. Every school focuses on developing strong student character, personal responsibility, and community/world involvement.</p> <p>E.
